Dear Ms Brown:

The Watchdog has reviewed your response. While we appreciate the difficulties of your position, and we do not hold you personally accountable for the actions of others you do not control, we must make abundantly clear that the County's response is clearly insufficient and could not possibly bear scrutiny.

Given the failure of the subject projects, it is a matter of grave concern if it turns out that salient responsive records have been unlawfully withheld or destroyed.

The County stands in obvious default with respect to item #1 in our request. We have proof of the existence of a number of responsive documents that your response fails to mention, including email communication (notably but not exclusively with BREC, Penelec and township supervisors), invoices and receipts from law firms and other providers, applications, and other materials directly pertaining both to the failed solar projects, and also the solar-related PUC litigation the County initiated (and funded) against BREC, then abandoned.

I suggest you discuss the matter directly both with Commissioner Dallara, whose name appears on some of the material we have already acquired, and the County Solicitor. We would also remind you that the law requires the county to assert any exception under §708 of the law.

I would also clarify that the Commonwealth Financing Authority (CFA) functions under the direct auspices of the DCED. It is legally impossible that the County does not have the CFA applications, supporting materials and correspondence responsive to item #2 in our request.

Should the required records not be produced, we will initiate litigation through the Office of Open Records to compel production of the public records under the law. We will inform the Inspector General's office, which is already investigating the non-performance of the CFA grants in question. Moreover, should it become clear that salient records have been destroyed, we reserve the right to alert law enforcement, including the Public Corruption Unit of the Attorney General's Office.

You write:

"I have been having problems pulling everything together and need at least an additional week to see if there is additional information pertaining to your request on the solar system."

We know there is a great deal of additional information. While we do not doubt your efforts, and we have no problem allowing you an additional week, please note that we face an Office of Open Records Appeal deadline that is inflexible.
